The CBCA Book of the Year Awards are Australia's most prestigious and longest running literary prizes.

The monetary prizes seek to support authors and illustrators in "the advancement, improvement and betterment of Australian Children's literature". The CBCA Book of the Year Awards were first presented in 1946, recognising children's books c the highest literary and artistic merit. Past winners include a 'who's who' of Australian greats, including Bob Graham, Patricia Wrightson, Ruth Park, Ron Brooks, Margaret Wild, Paul Jennings.

The winner of each Book of the Year category currently receives \$12,000, with honour books receiving \$4,000 with a total prize pool of over \$105,000.
