The CBCA Book of the Year Awards connect young people to great literature. During CBCA Book Week we celebrate reading for pleasure and applaud our awarded books.

Our Shadow Judging program is an exciting addition to our annual calendar. We are inviting young voices from across Australia to join the conversation about the books on our CBCA Book of the Year Shortlist. At the end of CBCA Book Week at our Shadower's Choice Awards winners chosen by our young groups of judges will be announced.

Australian children's literature plays a unique role in our culture. It has the power to shine a light on our world, speaking directly to young people.

By connecting kids, books + creatives, while strengthening young voices, our young participants will:

- > build personal aesthetic literary appreciation
- > be encouraged to imagine, think critically and respond creatively
- > develop a greater self-concept, empathy and awareness of diverse opinion
- > read more widely
- > absorb culture in a community context by sharing the experience

The program in 2022 >

All participating groups of young people, our 'Shadow Judges' will:

Read the 6 **Shortlisted** books in their nominated **category from 2022 CBCA Book of the Year Awards (BOYA)**

- ▶ Discuss these titles with their peers against the CBCA Book of the Year Awards criteria,
- ▶ Share a creative response, and
- ▶ Vote for their winners.

The Shadowers' Choice Awards will be announced and celebrated at a brand-new event at the end of CBCA Book Week 2022 on August 26.

TO APPLY AS A FUNDED GROUP >

We thank the Australian Government RISE Fund and our Supporters for providing the opportunity to build our program, website, and resources and to provide support funding for 115 reading groups from a range of areas across Australia including early childhood centres, schools, home schools, public libraries and community groups.

Each funded group will be supported with:

- ▶ **A \$120 voucher** for one set of books from a shortlisted category. To be redeemed at a local bookstore (ABA member bookstore)
- ▶ **A \$600 voucher** to support a writer and/or illustrator workshop with your group
- ▶ **Access to special supporting resources**

A description of why your group should be chosen (up to 400 words maximum)

▶ **State Coordinators:** Are on our National Committee. They are the coordinators of the program within your branches. They will disseminate information from our national office.

▶ **State Mentors:** Are coordinated by your State Coordinator. They will be assigned by Branches to groups to support Group Facilitators with information and strategies for eliciting responses to literature from young voices.

▶ **Group Facilitator:** An adult: On site/within participating organisation (early childhood centre, community group, public library, primary school, high school...) who provide the space, resources and guidance for the groups of young people.
